## Opt-Out Procedure

### Instructions – Please read carefully

- The Parent or Legal Guardian of the Participant is to **print a paper copy** of the form on Page 2, complete and sign it.
- The Participant is to bring the completed form with them on the day of the event or program, and hand it in at the sign-up desk.
- If two children from the same family are participating in the event or program, a form must be completed for each.

### NEXUS Digital Images Policy

Digital images (photos/video clips) taken during the clinics may be posted to our **Nexus Volleyball** website, and Facebook and/or Instagram accounts. Names or other personal identification of student participants **will not** be used.

**Note:** Persons who register their children for **NEXUS Clinics** or individual coaching do so by choice and can read the NEXUS Digital Image Policy on the registration pages of the website. NEXUS will not be held responsible for digital images taken by phones or cameras of attendees of our Clinics or members of the public.

### Photography/Videography at Events and Programs

**NEXUS Volleyball** may arrange for a photographer and/or videographer to attend our event or program specifically to take photos for the **NEXUS** website and social media accounts. These photos are taken for the purposes of recording key moments during the event or program and furthering the business success of **NEXUS Volleyball**.

**NEXUS Volleyball** will take reasonable steps to prevent images of the Participant[s] herein named, from being posted on the NEXUS Website, and Facebook/Instagram pages. **This does not constitute a guarantee.**

Photos and videos that capture the Participant throughout the day engaged in activities with other attendees cannot and will not be avoided.

**NEXUS Volleyball** make **reasonable, best efforts** to:

1. Instruct its own photographer/videographer to exclude the Participant from posed group/team shots.
2. During the selection process for online posting, exclude images where the Participant is the only individual captured in candid or action shots.

If, by chance, an image is posted that is of concern, the Parent or Legal Guardian of the Participant must advise NEXUS Volleyball *in writing*, and that image will be removed from the NEXUS website and social media accounts.
